# A Message from **SVHC** Leadership

When we look back on all the awards received and advancements achieved by the Southwestern Vermont Health Care clinical staff and administrative leaders in 2021, it is easy to forget there was a pandemic taking place.

Simply put, our staff's ability to continually adjust to emerging needs while maintaining the highest quality of care was awe inspiring.

This year, in particular, we were grateful their work caught the attention of numerous prestigious national organizations, as they are so very deserving of praise and accolades.

### New residency program for nurses

To support new nurses as they navigate their way through their first year, SVMC launched a **Transition** to Practice Program. The state's only nationally accredited transition-to-practice residency, the program combines classroom learning and hands-on experience, offering participants valuable clinical experience before they start working and beyond.

### DAISY Award recognizes extraordinary nurses

Part of a national merit-based recognition program, SVHC instituted **DAISY Awards** in the fall of 2021 to recognize the skill and compassion of the organization's many nurses. Anonymously nominated by colleagues, patients, families and physicians, winners may be individuals or nursing teams.



# Creating a culture of excellence

In 2021, SVMC joined an elite community of only 28 hospitals worldwide to receive a fifth designation from the American Nurses Credentialing Center's Magnet Recognition Program®.

Lauren Beck, RN, says the recognition is a direct reflection of the hospital's commitment to its nursing staff. "SVMC is one of those rare places that encourages and fosters nurse involvement at every level. We have a place at the table where our opinions are heard and can impact policy as well as initiate nurse-driven projects."

Beck adds, "Facilities undergoing Magnet® redesignation must provide evidence that their nursing teams have sustained and surpassed their execution of Magnet® standards since the previous review. To have our efforts recognized at an international level for a fifth time is both satisfying and validating."

### Katharine Green receives national recognition

Katharine Green, BSN, RN, was one of only 20 nurse leaders from the across the country to be named a **Young Professional Voice** by the American Organization of Nurse Leaders which recognized her exemplary leadership and demonstrated innovation, influence, and inclusion.



### Tuition reimbursement and sign-on bonuses

Recognizing that nurses are the backbone of care at SVHC, the organization instituted a robust tuition reimbursement initiative (up to \$60,000) as well as sign-on bonuses for both experienced and new graduates. While other institutions experienced nursing staff losses, SVHC's retention rate remained strong.

# Improving outcomes through inspired innovation

When SVMC's leadership noted an increased rate of chronic illness associated with advanced aging, they launched a program to keep older adults out of the hospital. The program, called Transitional Care, has continued under the leadership of Chief Nursing Officer and Vice President for Patient Care Services Pamela Duchene, PhD, APRN. By pairing transitional care nurses with primary care providers, the program identifies problems, reduces readmissions, addresses medication complexities, and improves patient satisfaction. The innovative thinking and responsiveness by leadership captured the attention of the American Hospital Association (AHA), and in February 2021, SVHC was honored to receive AHA's Rural Hospital Leadership Award.



Advancing Health in America



The Southwestern Vermont Regional Cancer Center's commitment to excellent care and support was recognized by the American College of Surgeons which granted it a three-year accreditation. Requiring a multidisciplinary approach to treating the complexity of cancer, the accreditation validates that SVRCC patients are receiving the very best care possible.

### Renal Dialysis earns high marks

SVMC's Renal Dialysis Unit earned a prestigious five-star rating based on clinical quality and patient experience from the Centers for Medicare and Medicaid Services. In addition to this accolade, the department underwent a rigorous three-day survey and licensure review and was determined to be deficiency-free.



### SVMC Cardiology receives accreditation

A thorough review of the SVMC Cardiology's operational and technical processes resulted in the department achieving the Intersocietal Accreditation Commission's accreditation for adult transthoracic and adult stress echocardiography. One of only five facilities in Vermont to achieve this honor, the accreditation recognizes quality care in compliance with national standards.

### Lown Institute

In 2021, SVHC was honored, once again, to receive an "A" value rating from the Lown Institute. This rating reflects SVHC's avoidance of unnecessary care and its ability to achieve good outcomes without overspending.

# A celebrated commitment to safety

When the American Nurses Credentialing Center reached out to SVMC to share news of their fifth Magnet<sup>®</sup> designation in 2021, they made special note of the organization's **exceptional nursing safety practices**.

"To be identified as 'exemplar' in our safety practices was incredibly rewarding to our entire team, as it reflects an ongoing and concerted effort to provide the safest possible care to our patients," says SVHC Director of Quality Paula Seaman.

The commitment to safety was further recognized by the Leapfrog Group, an independent national watchdog organization, which awarded SVMC an "A" for hospital safety. Ratings are based on performance in preventing medical errors, injuries, accidents, infections, and other harms to patients.

"This recognition reflects the culture of safety and high reliability that we have been actively cultivating at every level," says Seaman. "Everyone in the organization has a critical role in creating a safe environment and the outcomes and accolades are proof that our approach, and every individual, has an impact."

# A proactive approach leads to better outcomes



Southwestern Vermont Health Care (SVHC) primary care practices have always strived to provide care that is respectful of and responsive to patient needs. In recent years, the practices implemented a more proactive approach to care.

As Robert Schwartz, MD, Southwestern Vermont Health Care's Medical Director for Primary Care explains, "By engaging a team made up of front desk staff, nursing professionals, behavioral health specialists, diabetes educators, nutritionists, nurse case managers, social workers, and doctors, we're able to positively impact patient health outside of their office visits. Through outreach and individualized attention, we're providing better patient experiences and outcomes."

Those efforts were nationally recognized by the National Committee for Quality Assurance (NCQA) which re-designated SVHC's five Vermont-based primary care practices as Patient Centered Medical Homes.

"The NCQA sets a very high bar for this honor," says Schwartz. "Their recognition is a testament to tremendous commitment and teamwork and serves as an assurance that we are meeting the highest quality standard for our patients."

All-new options for hand surgery and therapy Patients needing hand surgery or therapy no longer must travel great distances for care. In 2021, Dr. David Veltre of SVMC Orthopedics began offering in-office options for procedures previously performed at the hospital. In addition, SVMC Outpatient Rehabilitation's Michaelia St. Jacques, OTR/L, completed training as a Certified Hand Therapist, ensuring patients receive the most advanced hand therapy techniques in the region.





### Enhanced recovery after C-section

Women undergoing cesarean sections at SVMC are returning home more quickly than in the past thanks to a new program that includes more education and preparation before surgery, reduced use of narcotics during surgery, and individualized post-operative care. Patients appreciate shorter hospital stays and a quicker return to normal activities.

# American Cancer Society selects SVMC for colorectal cancer initiative

SVMC was honored to be one of 20 hospitals chosen by the American Cancer Society to participate in the three-year project to **increase colorectal cancer screening rates**. The aim of the project is to bring well-performing health systems together to share tools, resources, and capacity-building assistance and to solidify evidence-based methods to improve community health.

Earning a spot on the prestigious list requires that a minimum of 400 randomly selected employees provide largely positive feedback on a series of confidential, in-depth surveys. Conducted by a third-party agency, the surveys cover all aspects of the workplace environment, including leadership, supervisors, co-workers, tools and resources, satisfaction, benefits, and more.

# Learning Tree Childcare Center earns five stars

At a time when nothing was certain for so many, the Learning Tree Childcare Center offered families and children in Bennington a much-needed constant: exceptional child care.

In 2021, that care was recognized by the Vermont Step Ahead Recognition **System** (STARS) which awarded it the highest possible rating of five stars.

According to the Center's director Nancy Noel, "The STARS program recognizes the efforts our entire staff makes to provide care that far exceeds the basic requirements. Towards that end, staff completed over 500 hours of professional development and more than 10 college classes collectively, much of it focused on supporting the social-emotional needs of our children and developing effective ways to remain connected with parents while social distancing was in effect."

In addition to creating a dedicated Facebook page for Learning Tree families, the center invested in new play structures to provide more safe outdoor learning and play opportunities.



### Senator Leahy secures funds for expansion of The Learning Tree

Recognizing the importance of child care to communities and employers, U.S. Sen. Patrick Leahy announced the inclusion of \$750,000 in a Senate spending bill for a significant expansion of the Learning Tree Early Education Program. In addition, Senator Bernie Sanders secured an additional \$77,000 of federal dollars for the effort. The expansion will enable the Center to nearly double its care capacity for children between the ages of six weeks to five years old. Currently located in the oldest building on campus, the Center may be relocated on campus or to the former Southern Vermont College campus. Either way, the designated funds will address a critical need for the community and hospital workforce.





rarely bestowed 5-star rating from the Centers for Medicare and Medicaid Services (CMS). A 5-star rating is the CMS's top mark. Since partnering with Allaire Health Services, CLR has bolstered its infectious disease prevention effort, with a focus on early detection, prevention, and control of diseases in a post-COVID world, while also working to combat resistance to antibiotics. In addition, the Center's cardiac program has been enhanced to provide extensive care for patients experiencing heart conditions.

### Women's health goes online

In February 2021, SVHC hosted four informational webinars designed to help women throughout the region improve their physical, emotional, and social wellbeing. Led by SVHC medical staff, the free webinars featured a presentation and a Q&A session. Featured topics included sexual health, social health, opioid safety, and opioid recovery.



### New parents find help at home

In an effort to help new parents and parents-tobe access information they need while observing COVID protocols, SVHC transitioned their new parent classes to an online format. Ranging from two to three hours and hosted by SVHC RNs, classes covered Hospital to Home, Childbirth Education, and Breastfeeding for New Parents.

# Keeping the lines of communication open

"Staying connected to community is always important," says SVHC Chief Medical Officer Trey Dobson. "It's especially true in times of crisis."

In an effort to combat the sense of uncertainty and isolation many were feeling in early 2021, SVHC launched a weekly interactive digital program called Medical Matters Weekly. Hosted by Dobson, the medicalthemed talk show features a variety of guests ranging from traditional and holistic medical experts to Olympic athletes to COVID survivors and offers a behind-the-scenes perspective on health care and the interesting personalities driving change within the industry.

Garnering more than 1,100 views on Facebook and YouTube and 1,200 podcast downloads, the 30-minute program quickly gained a loyal following, with viewers especially appreciating the ability to engage with the host and guest in real time via the chat feature on Facebook.

### SVHC Today goes virtual

At a time when there were more questions than answers about COVID, SVHC delivered muchneeded information and insight to the communities it serves by taking SVHC Today virtual. Panelists-including SVHC's chief medical officer, an infectious disease physician, and primary care providers from the region-shared the latest advice on travel, vaccinations, COVID and flu prevention to virtual audiences in Bennington and nearby towns; Manchester and the Northshire; Wilmington and Deerfield Valley; Williamstown and the northern Berkshires; and Hoosick Falls.



# Listening and responding to community needs

"Understanding the key health needs of the community we serve is always a priority," says Caitlin Tilley, Director of Care Coordination. Toward that end, SVMC conducts a comprehensive tri-annual Community Health Needs Assessment (CHNA). Using data gathered through

community forums and online surveys, the organization determines the priority health needs and invests in community health projects, organizations, and initiatives aimed at addressing the revealed issues.

"This past year, we made a concerted effort to include underrepresented segments of the community to reveal what disparities exists," says Tilley. "In the past we relied on community partners to share this insight, but we knew we could do better. We promoted response to the survey through posters with QR codes at COVID vaccine sites, including the COVID Resource Center, and provided access to technology, if needed, so individuals could complete the survey while waiting after receiving their vaccination."

This inclusive approach will inform and guide the work done, both within and outside of the hospital walls, to address emerging and ongoing health issues.

### Surveys and forums go to the source

In early 2021, SVHC hosted a series of CHNA online community **forums** in each of the five regions it serves. Participants shared healthcare experiences and discussed ideas for improving the health of their specific community. In addition, a digital survey promoted extensively in local media, on social media platforms, and on the health system's website, captured feedback from nearly 1,650 individuals.

### Community concerns revealed

When asked "what are the top three health needs that you feel should be prioritized and addressed in your community?," survey respondents shared the following concerns:

Mental health Community cohesion, gathering

Substance abuse Environmental health

Affordable housing, homelessness Primary prevention, healthier behavior

Domestic violence Transportation LGBTQ health Access to care



### Acting on insights gained

In response to the CHNA information, SVHC initiated several efforts. These include:

★ *Healthy+* magazine: a free community health magazine that speaks to health needs and connects readers with available resources and services.

★ Enhanced Mental Health Services for Children: SVHC is working to ensure that the services, resources, and settings children and families need to deal with mental health crises are available.

### **★Advanced Harm-Reduction Training**:

SVHC is working to prevent overdose fatalities in the community by providing CPR and Narcan administration training to individuals connected with others struggling with substance use disorder.





### SVMC doctors and nurses among first to receive vaccine

The same day doses of Pfizer-BioNTech COVID-19 vaccine, which had received emergency use authorization from the U.S. Food and Drug Administration, arrived on the SVMC campus, a total of 75 physicians and nurses, all of whom worked directly with COVID-19 patients, volunteered to be the first to receive the vaccine.



### Protecting our youngest

As soon as vaccines for children were approved, SVHC hosted two special clinics for children ages 5-11. Accompanied by their parents or legal guardians, more than 1,500 children from the region received the vaccine.



As the COVID-19 pandemic raged on and new variants emerged, SVMC sought ways to provide testing and vaccines to the maximum number of community members. In a welcome twist of good fortune, the gymnasium on the newly acquired Southern Vermont College campus proved to be an ideal venue for **mass vaccine** administration and testing.

The spacious facility allowed for social distancing and seven vaccination stations. At its peak, the site was open seven days a week and staffed by a combination of clinical staff and employees from literally every department of the hospital.

"It was no small feat to build an operation of this scale," says Gail Balch, RN, and Director of IT, Clinical Informatics. "It required integrating and managing multiple systems to handle scheduling, documenting administration, managing inventory, and tracking all those efforts. While the task was daunting at times, it was heartening to see so many people, from 100-year-old community members to small children, flowing into the COVID Resource Center (CRC) to protect themselves and the community. Even now, the center continues to be a shining example of ingenuity, teamwork, and excellence in caring."

# I got my COVID-19 vaccine!

### Addressing disparity in COVID prevention

When Patricia Johnson, RN, learned that Vermonters of color were disproportionately contracting COVID and dying at rates three to four times higher than Caucasian people, she volunteered to be among the first providers at SVMC to be vaccinated. In addition, she started a Facebook group to share information in a way that Black, Indigenous, and People of Color (BIPOC) Vermonters could relate. The goal of the group is to increase awareness, promote education, and facilitate outreach to address racial/ethnic minority health equity in Vermont. Working with the Rutland Area NAACP and the Vermont Department of Health, Johnson helped organize four Bennington-based vaccine clinics for the BIPOC community in the spring of 2021.

# Meeting the demand for testing

Throughout the pandemic, SVHC's **COVID testing** was utilized by tens of thousands of locals from throughout the SVHC tri-state service area and even drew in people from CT, NH, and RI, as well as international college students seeking tests.

Initially located on the SVMC campus, the testing center was relocated to the former Southwestern Vermont College campus in September, as variants emerged and the demand for testing increased. Situated above the COVID Resource Center in the parking lot of the Everett Mansion, the testing center operated six days a week. The 8–10 person testing team worked tirelessly to administer and prepare tests for processing. On many days, cars were lined up well in advance of the center's hours of operation.

"As challenging as the work was, it was also rewarding," says Patricia Bradley, Co-Operations Director, COVID Resource Center. "Every day people expressed their thanks that we were there to make testing so easy and accessible. It felt good to know that we had a part in keeping people healthy and controlling the spread of the virus."



Snow, ice, wind, and bone-chilling temperatures did nothing to diminish the demand for COVID testing. To ensure the COVID testing team was as safe and comfortable as possible, the testing site was outfitted with heating units and the team was provided with winter wear to protect them from the elements.







For more than 25 years, thousands of patients have counted on Southwestern Vermont Regional Cancer Center (SVRCC) for exceptional care and compassion at a difficult time. But we are rapidly approaching maximum capacity for treatment and infusion services. In 2024, we will begin significant renovations to allow for expanded medical oncology services. When completed, the renamed Hoyt-Hunter Cancer Center will include:

- · Double the number of exam and infusion rooms to help meet growing demand
- Individual treatment spaces to enhance patient privacy during crucial patient-family-provider discussions
- New check-in and check-out areas designed to provide efficiency, privacy, and improved patient experience
- New patient spaces designed with natural light and scenic views in mind to capitalize on nature's proven ability to reduce pain and nausea
- · A dedicated parking area and entrance

According to Dr. Matthew Vernon, Radiation Oncologist at the Center, "This renovation is so very welcome, as it will greatly improve the care experience on many levels. First and foremost, with more treatment spaces, we will be able to decrease the time it takes for patients to begin treatment as well as care for more patients overall. Additionally, the new exam rooms will decrease wait times and streamline the experience for patients being seen in clinic, both at the time of diagnosis and in ongoing follow-up. Staff, too, will benefit from a more spacious and inviting environment in which to work."
